East Polk Canine Kennel Boarding Contract

This is a contract between EAST POLK CANINE KENNEL and the pet owner(s) whose signature appears below (hereinafter called "Owner").

- © OWNER agrees to pay the rate for boarding in effect the date the pet is checked into EAST POLK CANINE KENNEL, and further agrees to pay for all costs and charges for any special services requested, and all veterinary costs for the pet during the time pet is in care of EAST POLK CANINE KENNEL.
- © Owner agrees to communicate with EPCK and to arrive by appointment during our open hours or be subjected to pay an inconvenience fee.
- © OWNER agrees that the pet shall not leave EAST POLK CANINE KENNEL until all charges for boarding, medicine, veterinary services, etc., are paid to EAST POLK CANINE KENNEL by OWNER. If the pet is not called for within 10 days of the stated pick up date, the pet will be sold for bills dues or placed with a humane society or rescue group. OWNER shall be liable for any unpaid charges.
- © OWNER is aware that if pet is found to have fleas or evidence of fleas, that the owner or emergency contact will have to come pick up the dog immediately. Owner is aware that

EAST POLK CANINE KENNEL requires the pet have a flea shampoo or flea treatment **before** being admitted to the kennel.

- © When requested, EAST POLK CANINE KENNEL will board more than one pet of the same species, from the same household, in a single kennel; however EAST POLK CANINE KENNEL reserves the right to place the pets in separate kennels if they deem necessary. The single kennel rate will then apply to each pet.
- © If pet is to be boarded any time over holiday periods, I, OWNER, agree that I will pay for ALL DAYS reserved, unless said dates are cancelled at LEAST 72 hours prior to the day of reservation.
- © EAST POLK CANINE KENNEL will exercise due diligence and reasonable care for pet. EAST POLK CANINE KENNEL will keep facility clean and properly enclosed.
- © If pet becomes ill or if the state of the pet's health requires professional services of a veterinarian or administer medicine, or a special diet, or give other requisite attention to the pet and the expenses thereof shall be paid by the OWNER.
- © All pets are boarded by EAST POLK CANINE KENNEL without liability on our part for loss or damage from disease, death, running away, theft, fire, injury to persons or other animals or property by said pet, fencing climbing, or other unavoidable causes, due diligence and normal care and caution having been exercised.
- © It is expressly agreed by OWNER and EAST POLK CANINE KENNEL that EAST POLK CANINE KENNEL liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per pet boarded. The OWNER further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of EAST POLK CANINE KENNEL.

- © By signing this contract and leaving your pet with EAST POLK CANINE KENNEL, OWNER certifies to the accuracy of all information provided about your pet, that pet is current on all vaccinations required by EAST POLK CANINE KENNEL, that pet has not been exposed to Rabies, Distemper, Bordetella or Canine Influenza within a 30-day period prior to boarding, and that OWNER is the legal owner of said pet, free and clear of all liens and encumbrances and assumes financial liability for all payments called for this agreement.

Bordetella, also known as canine cough, in dogs can cause a number of symptoms, including:

A persistent, dry cough that may sound like a goose honking or your dog is choking. A runny nose, eye discharge, Fever, Decreased appetite, Lethargy, Sneezing

In mild cases, dogs may continue to be alert, active, and eat. However, in more severe cases, symptoms can progress to pneumonia, lethargy, and even death. Immunocompromised animals and young puppies are more likely to experience severe symptoms. Bordetella is highly contagious and can be spread through contact with other dogs, such as at dog parks, groomers, boarding facilities, walking past an infected area, using an infected dog's water bowl, playing with an infected dog, your infected clothes, and even at the vet's office. If your dog shows symptoms, you should isolate them from other dogs and pets. Absolutely don't bring them to board or daycare. Many cases of Bordetella will resolve on their own, but a veterinarian can prescribe antibiotics to help your dog recover more quickly. Cough suppressants and anti-inflammatories can also help your dog feel more comfortable.

- © This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of the OWNER and EAST POLK CANINE KENNEL.
- © Any controversy or claim arising out of or relating to this contract, or breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party of this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by an arbitrator may be

entered in any court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

- © This contract applies to this stay at EAST POLK CANINE KENNEL as well as all subsequent stays.
